Kia ora e te whanau

The first quarter of the TM year always seems to go by at lightning speed and it takes the reflection time of writing these reports to realise how much our members and district have accomplished. The enthusiasm and passion of members is always so inspiring and a great reminder of why I love this organization. There was certainly a great deal of passion from clubs and members around the contest programme for the year and whilst the outcome may not have been what some wanted, the critical factor for me was knowing clubs had their voice heard and spoke with passion through their area directors at the first DEC of the year and also prior to the DEC in emails to me. It is a critical and essential part of the role of an AD which I certainly expect to be fulfilled. Andrew and Leonie – a huge shout out to you for your early work submission of reports.

Thanks to all who have supported COT, it takes a village and we need our village to grow and support each other, along with educating our clubs on best practice and what is required when it comes to club excellence.

Last shout out to Celina, who had a big job with the minutes of the DEC and keeps us all reminded of meetings and tasks we have to do – I certainly appreciate the reminders that come my way!
